**Fill the online form as per given schedule and Criteria by DTE or your form will be REJECTED.**

**Following are points be noted while filling online form: -**

- 1) While scrutiny if any application found with incomplete data or document it will be Sent Back to student's login and that student have to correct the data and Reapply the same form **immediately**. Therefore, every student has to check regularly his or her login until 25.10.2022. If any student application is Sent Back and if that student is not forwarding the same by doing the correction, in that case that student form will be rejected, if forwarded after last date. Student will be responsible for not getting benefit of scholarship and Institute will not be responsible for such case.
- 2) Non-Aadhaar student's application form will not forwarded, as they will not receive amount from Government. It will be student's responsibility to get their Aadhaar and Mobile Number linked with Bank. Institute will not entertain such instances if Aadhaar not linked to Bank.
- 3) While filling the online form in fee paid column student have to fill only tuition fee amount from your fee receipt and upload fee receipt.
- 4) Upload S.S.C., H.S.C. / Diploma Marksheet and other Marksheet, Domicile certificate of student and Income Certificate of parents (Scan Color copy).
- 5) Upload C.A.P. Allotment letter with College Confirmation letter on those student's C.A.P. Allotment letter Freeze and confirmed not mentioned.
- 6) Upload Marathi Undertaking with proper current year date, place and signature of student and parents.

If any student application form rejected for any reason by Government, student will be liable to pay full fees to the Institute within 15 days of Rejection.

#### **Rajarshi Chhatrapati Shahu Maharaj Shikshan Shulk Shishyavrutti Yojna (EBC) 2022-23,**

##### **Eligibility Criteria:-**

- a) Applicant should have Nationality of India.
- b) Candidate should be Domicile of Maharashtra State.
- c) Applicant should be "Bonafide Student of Institute" and admitted for Professional and Technical course (Diploma / Graduation) as mentioned in GR
- d) Deemed University and Private university is not applicable
- e) Candidate should be admitted through Centralized Admission Process (CAP).
- f) Applicant should not avail any other scholarship/stipend.
- g) For current Academic Year, Only 2 child from family allowed for benefit of scheme.
- h) The Total Annual Income of Family / Guardian should not be more than Rs. 8,00,000/- / Eight Lakhs.
- i) Minimum 75 % attendance in previous semester (Exception for fresh admitted in College).
- j) During course duration, candidate should not have a gap of 2 or more than 2 years.

- 4) **Domicile Certificate of Maharashtra State.** (Birth certificate and leaving certificate will not consider
- 5) **The Original annual income Certificate of parents** for the previous financial year 2021-22 duly certified by concerned Tahashildar upto Rs.8,00,000/- / Eight Lakhs.
- 6) **If income is less than 50% of tuition fee** than student must produce the undertaking of that person who provided financial assistant or if taken education loan from bank than bank certificate.
- 7) Ration Card (with student name mentioned in it) and **Undertaking (In Marathi)** "In current year, not more than 2 beneficiaries from family" and **other Undertaking in College Format.**
- 8) **If any gap,** then attached copy of gap affidavit.
- 9) **Father Death Certificate** (If attached Mother Income Certificate).
- 10) Photo copy of **Pass Book must be in the name of student OR cancelled cheque** (Name of the student, Bank name, Bank branch name, Account Number, IFSC CODE AND MIRC NO must be mentioned in it.)

- **Scheme - 2) Dr. Punjab Rao Deshmukh Hostel Maintenance Allowance Scheme. – 2022-2023,**  
All the First Year to Final Year students admitted through CAP Round of the college and staying in Hostel are hereby informed that, this is a plan for students of government, government funded and non-affiliated colleges / polytechnics entering the vocational courses set by the government, whose students are certified by the competent authority, as a marginal farmers or whose parents are registered laborers. They receive Hostel maintenance allowance from Directorate, Technical Education, Regional Office, and Mumbai for academic year 2022-2023.
