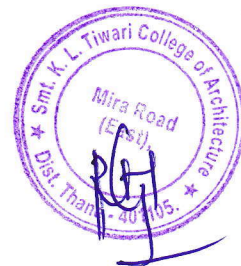

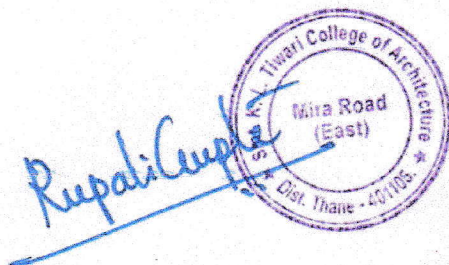

15. No objection, appeal or request from the student in regards to decision of the management council will be entertained under any circumstances.

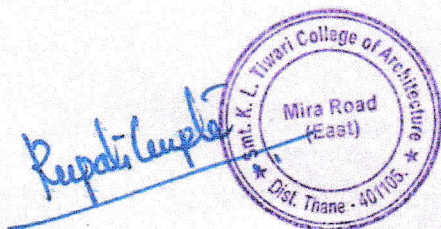
Management Scholarship/Freeship Scheme

About the Management Scholarship Scheme:

The Management scholarship scheme is named after the Founder-Chairman of Rahul Education - Shri Lallan R. Tiwari.

1. Sanction of amount for Freeship/Scholarship shall depend on Merit/Economical background of students applied.
2. Tuition fee is one of the components of the total fees which are to be paid through the online portal at the college office.
3. The student who wishes to apply for the scholarship must meet and fulfill the eligibility criteria.
4. On yearly basis students from the ARCHITECTURE College (UG & PG) shall be provided with the Management scholarship.
5. It is purely based on the academic merits, i.e. the performance of the candidate at the HSC Examination or Equivalent.
6. The application should reach the institution within 15 days from the date of confirming the admission at the college.
7. The scholarship form is made available at the college website <https://skltca.in/>
8. The scholarship selection committee would check the eligibility criteria and recommend the management for scholarship to the candidate.
9. The discretion of the management council would be final and abiding to the students who apply for the management scholarship.
10. No objection, appeal or request from the student in regards to decision of the management council will be entertained under any circumstances.

Eligibility Criteria for Scholarship



1. The students who have secured more than 95% in HSC Board Examination or Equivalent are eligible to apply for the Management Scholarship Scheme for waiver in the tuition fees for First year of Degree College. (Component of the total fees)
2. The candidate should be a fresh regular student who has appeared and passed for the 12th Standard examination.
3. The candidate should clear the 12th examination in first attempt.
4. Privately passed 12th standard candidates are not allowed to fill the scholarship form.
5. The Management scholarship scheme is open to all the reserve classes as well as open category students including Minority quota, In-house quota etc.
6. The candidate should provide with true and correct information in the scholarship form. Any erroneous or wrong information would amount to cancellation of the name from the nomination for the scholarship.

Memorandum of Understanding

Terms and Conditions to follow by FORSTUEDUTECH LLP.-

- 1) FORSTUEDUTECHLLP. Will get students enrolled from Smt. K L Tiwari Education Society's Smt. K L Tiwari College of Architecture, under its S2S Program / Scholarship Facilitation Center.
- 2) FORSTUEDUTECHLLP. Will take responsibility of forwarding application to all the private scholarships and financial grants of all the enrolled & eligible students from Smt. K L Tiwari Education Society's Smt. K L Tiwari College of Architecture.

Terms and Conditions to follow by College-

- 1) College will provide student details & documents required by FORSTU EDUTECH LLP.
- 2) College will be responsible to share the genuine & verified profile of the students and furnish all the documents required for students' profile on FORSTU portal.
- 3) Verification process for every scholarship donor is different, student's response is always needed for this process and college will be responsible to orient the students for such verification process.
- 4) If any extra details or documents needed for any scholarship process at any moment college will be responsible to furnish the details on behalf of their students.
- 5) Student will be responsible to pay 20 % of the scholarship amount to FORSTU EDUTECH LLP as its operational charges, after students receive any scholarship in any respective months during partnership tenure for S2S Program.

Confidentiality

All written and oral information, in whatever medium or form and specifically marked as Confidential, shall be held in strict confidence by all parties and be used only for purposes of this agreement. Except as required by law; no such information, including the provisions of this agreement, shall be disclosed by the recipient without the prior written consent of the other party. If either party is required to disclose any confidential information of the other party; the party so required shall notify the other party immediately and shall cooperate in seeking a reasonable protective order.

Force Majeure.

Neither party hereto shall be considered in breach hereof or in default if it fails to perform or observe any or all of the terms of this MOU resulting directly or indirectly, such as, but not limited to acts of God, Civil or Military authority, acts of Government, acts of Public Enemy, war, riots, explosion, earthquake, flood, storm, lightning strike, etc. In such a case either party shall notify the other party of the occurrence of such cause and should as a consequence, the performance under this MOU be prevented for a period longer than three months, then the other party shall have the right to terminate this MOU.

Intellectual Property Rights

FORSTU EDUTECH LLP, hereby undertakes and agrees that it possess and at all times, retain all rights, title and interest including intellectual property rights in all material deployed by it during the implementation of the Project. Smt. K L Tiwari Education Society's Smt. This MOU is executed on a principal-to-principal basis and nothing in this MOU is intended to, or shall be deemed to; establish any partnership or agency or joint venture between the Parties. Neither Party will incur or assume any obligation and/or liability for and on behalf of the other Party.
